- Defendant agrees that he will testify truthfully in all hearings, trials, or settings involving any and all Defendants and co-Defendants in the criminal matter.
- The Defendant shall pay a \$500 fine.
- The Defendant shall participate in a firearm safety course and present proof of completion to the District Attorney within sixty days of the acceptance of this plea.
- As part of this agreement, Defendant agrees to take responsibility for his actions or inactions.
- Defendant shall not possess or use any alcohol or controlled substance without a valid prescription.
- Defendant shall complete twenty-four (24) hours of community service.
- Defendant shall have no contact with any potential witnesses or co-defendants in this case.
- The State reserves the right to withdraw this plea and prosecute any and all charges supported by probable cause if Defendant violates the terms and conditions of this plea agreement, fails to testify at any hearing in the criminal matters, commits a new offense, fails to abide by conditions of release pending sentencing, fails to appear at any scheduled court hearing, or violates any terms and/or conditions of probation.

All outstanding warrants issued in this case shall be and are hereby quashed.

All active bonds posted in this case shall be exonerated/released to the original payor unless otherwise ordered.
