JUDGMENT AND SENTENCE, TRANSPORT, AND COMMITMENT TO THE N.M. DEPARTMENT OF CORRECTIONS

THIS MATTER came before the Court for sentencing on April 15, 2024. The State of New Mexico was represented by Kari T. Morrissey and Jason Lewis, Special Prosecutors. The Defendant was present, in-custody, and represented by counsel, Jason Bowles.

The Defendant was convicted on March 6, 2024, pursuant to a GUILTY VERDICT accepted and recorded by the Court of the following offense:

COUNT 1: INVOLUNTARY MANSLAUGHTER (0007), as charged in Count 1 and its alternative of the Third Amended Criminal Information, filed June 22, 2023, a 4th degree felony, occurring on or about October 21, 2021 in the County of Santa Fe, State of New Mexico, contrary to NMSA 1978, §30-2-3(B) 1994.

The Defendant is hereby found and adjudged guilty and convicted of this crime.

COUNT 2: TAMPERING WITH EVIDENCE (4230), the Defendant was acquitted pursuant to a jury verdict of NOT GUILTY.

IT IS THE JUDGMENT AND SENTENCE OF THE COURT that the Defendant be committed to the custody of the Department of Corrections where the Defendant shall serve eighteen months incarceration as to Count 1 of the Amended Criminal Information. Upon release from this period of incarceration, the Defendant shall be placed on one year of parole, subject to the terms and conditions set by parole authorities.

THE COURT FURTHER FINDS that this conviction is a Serious Violent Offense pursuant to NMSA 1978, §33-2-34(L)(4)(o). The Court finds the offense occurred in a physically violent manner. The Court finds that the defendant allowed a fatal gunshot to occur that was done with recklessness in the face of knowledge that the Defendant's acts were reasonably likely to result in serious harm.

IT IS FURTHER ORDERED that Defendant shall receive presentence confinement credit for 40 days from her remand after conviction on March 6, 2024 through the date of sentencing on April 15, 2024. Defendant shall also receive presentence confinement credit from April 16, 2024 until she is transported to and taken into custody by the N.M. Department of Corrections.

IT IS FURTHER ORDERED that Defendant shall pay fees in the amount of a \$5.00 Domestic Violence Treatment Fee; and a \$75.00 Crime Victim's Reparation Fee.

IT IS FURTHER REQUIRED that pursuant to §31-17-1 NMSA, the Defendant shall pay restitution in accordance with a plan designated by the Adult Probation and Parole Office.

IT IS FURTHER ORDERED that the Defendant shall provide a sample of biological material sufficient for DNA testing and shall pay a fee of \$100.00 for the combined DNA Index System (CODIS) to the Probation and Parole Division of the New Mexico Corrections Department, pursuant to the DNA Identification Act, §29-16-1 et seq., NMSA 1978.

IT IS FURTHER ORDERED that the Santa Fe County Sheriff's Office are hereby

commanded to take the above-named Defendant into custody and transport her to the New Mexico

Department of Corrections for the term designated above.

IT IS FURTHER ORDERED that all outstanding warrants in the above-captioned cause

are hereby canceled or quashed and are to be removed from all law enforcement databases and any

bond in this matter is hereby discharged.

The Defendant is advised by the Court of Defendant's right to appeal the judgment and

order of this Court. If the Defendant is unable to pay the costs of an appeal, the Defendant has a

right to proceed with an appeal at the State's expense and at no cost to Defendant. Further, if any

appeal is to be taken, it must be filed within thirty (30) days of the date of the filing of this Judgment

and Sentence.

IT IS SO ORDERED.
