Glossary

Active pending: Active cases awaiting disposition at the end of the reporting period.

Age of active pending cases: Average age of the active cases before a court, as measured in active days from filing until the end of the reported fiscal year.

Begin pending: Active and inactive cases awaiting disposition at the start of the fiscal year.

Closed: Cases that have been resolved and a disposition entered.

Disposition rate (also clearance rate): The percentage of outgoing cases compared to incoming cases. Outgoing cases are those that have been resolved and those placed on inactive status. Incoming cases are new filings along with reopened and reactivated cases.

End pending: Active and inactive cases awaiting disposition at the end of the fiscal year.

Inactivated: An administrative status for cases in which the court can take no further action because of events outside of its control. For example, a civil case becomes inactive if a higher court issues a stay. The case would be reactivated after the stay is lifted.

Incoming: Cases that have been added to a court's caseload — the sum of new filings, reopened and reactivated cases.

New: Cases newly filed during the reporting period.

Outgoing: Cases that have been removed from a court's caseload — the sum of closed and inactivated cases.

Reopened: Cases with a previous judgment that have been restored to a court's pending caseload because of the filing of a request to modify or enforce the judgment.

Reactivated: Cases that can resume and proceed toward disposition after a period of inactivity beyond a court's control. A criminal case is placed on inactive status, for example, if the defendant absconds after the case is filed. The case is reactivated when the defendant is apprehended and returned to court.

Time to disposition: The time – measured in active days – it takes to resolve a case from filing to disposition.

METHODOLOGY NOTE

Caseload and jury trial numbers in this report are based on a “performance measure” approach designed by the [National Center for State Courts](#). Prior to FY22, all Statistical Addendums were compiled using a different methodology, and caseload numbers in those reports do not include data on activated and inactivated cases.
