# STOP

## Please read this ADVISORY

1. REMEMBER – you are responsible for your case:
  - You must fill out the paperwork correctly,
  - You must request and attend hearings,
  - You must check whether the opposing party is filing paperwork
  - You must keep track of deadlines, etc.
2. READ the instructions. They are there to help you fill out these forms.
3. TAKE YOUR TIME filing out the forms. This paperwork will have some legal impact on your life.
4. Please, always use your case **caption** (example: Jane Doe v. John Doe, D-1329-DM-201300194) on all court papers, letters, and with the clerk's and judge's offices.
5. Please seek the advice of an attorney if:
  - a. you do not understand the forms
  - b. you are unsure about what to do
  - c. are uncomfortable with the information you must put on a form.

## INSTRUCTIONS FOR A PETITION FOR A NAME CHANGE

<p>✓ <b><i>STEP 1 – GETTING THE RIGHT FORM</i></b></p>	<p>This form is for you if the following is true:</p> <ol style="list-style-type: none"> <li>1. You wish to petition for a name change for a minor under the age of 14.</li> </ol>
<p>✓ <b><i>STEP 2 – FILL OUT THE PETITION</i></b></p>	<ol style="list-style-type: none"> <li>1. Completely fill out the Petition.</li> <li>2. The parent or guardian is the Petitioner who will sign the paperwork.</li> <li>3. Make two copies of your completed and signed Petition for Name Change. One copy is for your records. If the child has a parent or guardian who has not signed the petition, you have to give that parent notice by serving the second copy on the non-signing parent or guardian.</li> <li>4. If there is a parent who does not agree to the name change, fill out the Summons and make two copies.</li> <li>5. Once all this is done, you are ready to file the Petition for Name Change at your local district court. There is a filing fee of \$132. You must pay in cash or money order. If paying in cash you must bring exact change. No personal checks are accepted.</li> <li>6. You may fill out an Application for Free Process if you want to ask to have the fee reduced.</li> </ol>
<p>✓ <b><i>STEP 3 – FILE YOUR PETITION</i></b></p>	<ol style="list-style-type: none"> <li>1. Bring the original and two copies of the signed Petition (and Summons, if needed) to the court clerk's office.</li> <li>2. File the original and copies with the clerk's office.</li> <li>3. If both parents agree to the name change, the other parent can consent to the name change instead of being served. Proceed to step 5</li> </ol>
<p>✓ <b><i>STEP 4A – PERSONAL SERVICE ON NON-SIGNING PARENT</i></b></p>	<ol style="list-style-type: none"> <li>1. You must personally serve the non-signing parent or guardian with the Petition and Summons. (See attached "Giving Notice")</li> <li>2. Once the parent has been served, file the Return of Service with the court. Without service, the court will not grant the name change.</li> <li>3. The other parent has 30 days to respond after being served.</li> <li>4. If you do not know the address of the other parent you must publish in a local paper of their last known address.</li> </ol>
<p>✓ <b><i>STEP 4B- SERVICE BY PUBLICATION ON NON-SIGNING PARENT</i></b></p>	<ol style="list-style-type: none"> <li>1. If you are unable to serve the other parent personally or by certified mail, you will need to request permission from the judge to publish notice of your case in a newspaper.</li> <li>2. Completely fill out the Motion for Service by Publication. The Order for Service of Process by Publication in a Newspaper should be filled out completely, except the signature line for the judge. Also you will need to fill out the Notice of Pendency of Action.</li> </ol>

<p><b><i>STEP 4-B CONTINUED</i></b></p>	<ol style="list-style-type: none"> <li>3. Make a copy of all 3 documents and take them to the court clerk's office for filing, along with a self-addressed stamped envelope for the return of the documents.</li> <li>4. If the judge <b>grants</b> the Order for Service of Publication in a Newspaper, you will receive all your documents in the mail, along with the Notice of Pendency of Action issued by the clerk's office. Take the Notice to the newspaper that you indicated you were going to publish in the Order for publication. The publication must run once a week for <b>3 consecutive weeks</b>. <b>You</b> are responsible for paying the newspaper for the cost of publication.</li> <li>5. When publication is complete, the newspaper will send you an Affidavit of Publication. File this document with the court clerk's office before your hearing.</li> <li>6. If the judge does <b>not</b> grant the Order for Service of Process by Publication in a Newspaper, you will need to again try to serve the other parent or least again try to locate the other parent.</li> </ol>
<p>✓ <b><i>STEP 5– GO TO YOUR HEARING</i></b></p>	<ol style="list-style-type: none"> <li>1. Fill out page 2 of the Order for Name Change (A, B &amp; C if multiple children) and bring it with you to your hearing.</li> <li>2. The judge will review the Order, and may have questions for you.</li> <li>3. If the judge doesn't see any problems, the judge will sign the order.</li> </ol>
<p>✓ <b><i>STEP 10– FILE THE ORDER</i></b></p>	<ol style="list-style-type: none"> <li>1. After the judge signs the order, take the signed order to the court clerk's so they can officially file the order. Once the order is filed, the name change is official.</li> <li>2. Ask the court clerks to certify as many copies of the order as you need. You will need certified copies for schools, social security and the County Clerk. The fee for certified copies is \$1.50 per certification.</li> <li>3. Record a certified copy of the order with the County Clerk. The County Clerk is not the same as the court clerks. If you are not sure where your county clerk is located, check with the court clerk's office.</li> </ol>

# What Is “Giving Legal Notice” or “Service”?

---

**PETITIONER = YOU**

**v.**

**RESPONDENT = THE OTHER PARTY**

(your spouse, your ex-boyfriend, your ex-girlfriend, etc.)



## YOU MUST

- ✓ legally notify the Respondent that you have filed a petition (**Summons**)
- ✓ file proof with the Court that you notified the Respondent (**Return of Service**)
- ✓ have a copy of all the paperwork you filed  
**AND**
- ✓ a copy of all the paperwork the Court issued when you filed your petition, delivered to the Respondent

The Court **WILL NOT** do this for you

## How Do I Give Legal Notice?

---



### **PERSONAL SERVICE – COURTS PREFER**

Anywhere the Respondent can be found: For Example, at work, at home or other place.

1. Deliver a copy of all the paperwork to the Respondent using one of the following:
  - a. Sheriff's Deputy
  - b. Anyone (NOT YOU) 18 or older with a valid ID OR
  - c. A private process server
2. **You** yourself **CANNOT** serve the Respondent with the paperwork.

### **MAIL – NEXT BEST OPTION**

1. **You have a good address for the Respondent:**
  - a. send paperwork by **CERTIFIED MAIL – RETURN RECEIPT**.
  - b. The Respondent, and only the Respondent, must sign for the legal paperwork.
  - c. Restricted delivery to the Respondent helps.



### **NEWSPAPER – LAST RESORT**

**Q:** What if I don't know where the Respondent works, lives, or can be found?

**A:** You can ask the court's permission to publish in the newspaper. (*Motion for Service by Publication*) – The court **cannot** waive the publishing fee. You will have to pay this.

## I Served the Respondent, Now What?

---



### **FILE PROOF OF SERVICE**

**REMEMBER:** The Court doesn't know if the Respondent was legally notified unless YOU file the right paperwork at the court clerk's office that proves it.

1. **Return of Service Form** = Personal Service Complete
2. **Green Return Card** = Certified Mail **Signed by Respondent**  
**OR**
3. **Affidavit of Publication** = After Publication in a Newspaper

**ORDER FOR CHANGE OF NAME**

THIS MATTER came before the court for hearing upon a Petition for Change of Name.

The court examined the matter pursuant to NMSA 1978 Sections 40-8-1 to 40-8-3 and, being fully advised in the premises, FINDS:

1. This is a Petition for a name change involving a person(s) under the age of 14 years  
(parent/guardian filed for child)

2. Court finds:

Both parents/guardians signed the Petition; or,

The non-signing parent/guardian was properly served with a copy of the Petition for

Name Change and said parent/guardian was afforded sufficient time to respond to the Petition.

The Petitioner(s) has complied with all of the requirements of the law for service by publication, including the requirement of publication of Notice of Pendency of Action once a week, for three weeks in a newspaper of general circulation in all counties in New Mexico or where the other parent/guardian was most likely to be found if the other parent is not in the State of New Mexico.

3. No sufficient cause has been shown why the name(s) of the minor(s) should not be changed.

IT IS THEREFORE ORDERED that:
